5.6 RxChange Response Process

5.6.1 Fillable RxChange Response Process

The following RxChange Response types have the same workflow in VistA Holding Queue.

- RxChange Response Message – Approved response type for request types, D, T, G, S and OS
- RxChange Response Message - Approved with Changes (AwC) response type for request types, D, T, G, S and OS
- RxChange Response Message - Validated response type for request type U

The fillable change responses display in the Holding Queue List View screen as an actionable entries. They can also be found using <MV> Message View or <SR> Search.

The statuses of the RxChange Response Message – Approved and AwC response types for request types, D, T, G, S and OS, are CXN (RxChange Response - New). The status of the RxChange Response Message – Validated is CXV (RxChange Response – Prescriber Auth - New).

When a fillable change response is received, the original is canceled in the Holding Queue and discontinued in Outpatient Pharmacy (if exists), and the change response is to be treated exactly the same way as a NewRx wherein the pharmacy user would exercise actions such as <VP>, <VM>, <VD> and so on.

NOTE: The workflow of a fillable change response is very similar to that of a NewRx record. For complete details about how to process a NewRx record, refer to section [Error! Reference source not found. Error! Reference source not found.](#)

For the sake of training, a full life cycle of fillable Approved RxChange Response will be discussed further.

5.6.1.1 RxChange Response – Processing Error (CXE)

RxChange Response – Processing Error (CXE) is an actionable status used for fillable RxChange Responses if a failure occurs. One scenario is when a patient’s Outpatient Profile record is locked in OERR and a fillable RxChange Response is attempting to auto-discontinue an eRx record at the same time. Another scenario is when a RxChange Request is sent out for a prescription, and it is manually discontinued before a response is received. Then, a fillable RxRenewal Response is sent for the prescription.

When a fillable RxRenewal Response record is in CXE status, the user can still process that record similar to a NewRx record after manually canceling the original in the Holding Queue and in Outpatient Pharmacy (if a record exists).

5.7 Inbound Error – CRE
